### The 16-19 Bursary Fund

The Bursary Fund is designed to help support 16-19 year olds in full-time education with the costs of continuing education such as travel, books, educational visits and equipment. The scheme is funded by the ESFA (Education & Skills Funding Agency) to provide assistance to students whose access to, or completion of, education is inhibited by financial constraints or barriers.

The scheme is made up of two parts:

- **Vulnerable Bursary (Level 1)** - a payment of £1,200 to a small group of the most vulnerable students
- **Discretionary Bursary (Levels 2-4)** - for schools, colleges and training providers to distribute at their discretion. The discretionary fund is allocated to eligible students and is dependent on the amount of funding and number of applications received in the academic year.

### Eligibility Criteria for 16-19 Bursary Funding

**Students following government (ESFA) funded full time or part-time courses, who are 16 years and over and satisfy one or more of the following criteria:-**

- **For Level 1** – Students aged at least 16 and under 19 years of age on 31/08/22 who are in care, are a care leaver (defined as previously looked after for a period of 13 weeks consecutively (or periods amounting to 13 weeks), which began after the age of 14 and ended after the age of 16), are in direct receipt of Income Support (or Universal Credit) or are disabled and in receipt of both Employment Support Allowance and Disability Living Allowance (or Personal Independence Payment).
- **For Level 2** – Students who are economically or socially disadvantaged and at risk of not taking up or continuing in their education. This group includes students with physical or other disabilities, medical conditions and/or learning difficulties.

Students who have been in care, on probation, are young parents or are otherwise considered at risk.

UASC (Unaccompanied asylum seeking children) under the age of 18. Over the age of 18, UASC who have an asylum claim in their favour can receive the bursary; UASC who have had their "Appeals Rights Exhausted" (ARE), are not eligible.

Students with a total gross household income of less than £30,000.

### Applying for the 16-19 Bursary Fund

Students are encouraged to apply as soon as possible. The deadline for initial applications is 7<sup>th</sup> October 2022. Application forms will be sent out to all students in September and will also be available on the sixth form area of the school website. **Completed applications should be handed in to Miss Blunt.**

Each application will be reviewed by the Bursary Fund Application Panel and successful applicants notified by October half-term.

The Bursary Fund Application Panel will consist of: The Head of Sixth Form and School Finance Officer.

### How does The Coleshill School assess applications and allocate 16-19 Bursary funding?

Vulnerable students eligible for Level 1 will receive their bursary funding from a central fund held by the Learner

Support Service. Students eligible for a Level 2, 3 or 4 bursary will receive their bursary payment from The Coleshill School 16-19 Bursary Fund; this is a limited fund and the school will prioritise allocation in accordance with this policy. Payments will be made by BACS transfer directly into the student's bank account .

## What criteria do students need to meet for continued payment of 16-19 Bursary Fund?

Students' performance will be monitored and reviewed on a termly basis. Payments during each term will be based on the criteria outlined below for the previous term e.g. Spring and Summer term payment will be based on meeting the criteria throughout the Autumn term and Spring term respectively.

**Level 1 Bursary** – students will continue to receive the payment as long as they continue to attend The Arthur Terry School and are registered on a full programme of study (3 A Level subjects). Students will need to meet the basic expectations of all sixth form students as outlined in the code of conduct.

**Level 2, 3 and 4 Bursary** – students will continue to receive bursary fund payments if they:

- **Have an attendance rate of a minimum of 96%**
- Be punctual to all lessons and registration
- Attend all assemblies and enrichment sessions
- Complete a leave of absence in advance for any time you need to take off
- Meet expectations of all sixth form students as outlined in the code of conduct
- Make satisfactory progress against your targets and attend all examinations

### Bursary Fund appeals procedure

If a student wishes to appeal against the allocation of the 16-19 bursary fund this will need to be put in writing to the headteacher. Each appeal will be reviewed on a case by case basis against the published criteria for eligibility.
